Employment Health Services Contracted as Collection Site for Antibody Testing of COVID-19

Quest Laboratories has contracted with Employment Health Services as a collection site to test for antibodies of SARS-CoV-19 (COVID-19). This test, also known as a serology test looks for the presence of antibodies, which are specific proteins made in response to infections. Antibodies can be found in the blood and tissue of those who are tested after infection. The antibodies detected by this test indicate that a person had an immune response to SARS-CoV-2 (COVID-19), including those who may have experienced mild symptoms without a diagnosis, or never showed any symptoms at all.

It usually takes at least 10 days after symptom onset for IgG (Antibodies) to reach detectable levels. An IgG positive result may suggest an immune response to a primary infection with SARS-CoV-2, but the relationship between IgG positivity and immunity to SARS-CoV-2 has not yet been firmly established.

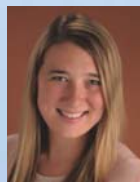
