- I. Call to Order Nick Klimek, President *8:00 am
 - a. Call to order: 8:01 a.m.
 - b. Welcome, Blake Olejniczak, new HSBPA Board Member

- II. Secretary's Report *8:03 am
 - a. Cindy S. made motion to approve March 2022 minutes. Tom V. seconded the motion. Motion carries.
- II. Treasurer's Report Connor Larsen *8:05 am
 - a. Newspaper Balance: \$6,048.00
 - b. Operating Balance: \$20,663.88
 - c. Charitable Balance: \$3,015.22
 - d. Casino Night: Revenue was nearly \$10,000, expenses were about \$1,600. Raised enough money to provide seven scholarships.

- III. HSSD School Board Garry Sievert *8:10 am
 - a. Garry S. is the HSSD Board of Education president and has been with HSSD for 43 years.
 - b. He provided a packet from Hanover, which includes data regarding student preparation, curriculum, experience, etc. within Brown County.
 - i. There is a committee formed to dive into Youth Apprenticeship opportunities.
 - c. Purpose of Garry's visit: To invite HSBPA board members and members to attend the Business & Workforce Development Community Conversation on May 11 at 8 a.m. in the HSSD District Office Training Center.
