 - i. Alternative solution would be to create separate entity (foundation) to gain 501(c)(3) status
 - 1. There would be a cost associated to apply for this entity and may still not get approved (approx. \$600)
 - 2. Annual cost to maintain entity as well
 - 3. Would allow HSBPA to do raffles at all events and keep all proceeds (within scope of association)
